17th March 1959

By a Deed of Grant of this date the within named William Neville Whittingham granted to the Ministry of Transport and Civil Aviation an easement for a 12" Storm Water Drain at Bramham - cum - Oglethorpe in the County of York and he acknowledged the right of the Ministry to production of copies of the within written Conveyance and undertook for the safe custody thereof.
